**Report of the CINP President**  
*John H. Krystal, M.D.*

My tenure as CINP President began following a very successful CINP World Congress held in Seoul, Korea under the leadership of Professor Shigeto Yamawaki.

### A. Attending to CINP

**Infrastructure Needs.** As I assumed office, I realized that CINP needed to focus on many aspects of its infrastructure in order to assure that it would continue to thrive as an organization. In the space below, I highlight a few areas of primary focus for CINP over the past two years.

**1. Selection of an Association and Conference Management Organization.** CINP has thrived under the expert care of its Central Office, led by CINP Executive Secretary Mrs **Gill Moore**. I joined a long list of CINP Presidents who relied heavily on Mrs Moore for guidance, assistance, and administrative support. Both personally and on behalf of CINP, I wish to thank Gill for her stewardship. However, several years ago, Mrs Moore informed us that she intended to retire at the end of the 2018 World Congress. In anticipation of this change, CINP initiated a search for an association management organization (AMO/CMO). In this process, many applications were received and five organizations were shortlisted and three interviewed. There were many excellent options and the CINP Executive Committee (EC) faced a difficult choice. I want to thank our EC members for the enormous amount of work involved in this process. I am pleased to announce that **International Conference Services (ICS)** was selected. We have already begun to work with Mr. **Christoph Raudonat** and his ICS colleagues toward the transition. I can assure CINP members that we are in capable hands going forward.

**2. Revising the CINP Constitution and Bylaws.** CINP is the oldest organization of its kind. Perhaps for this reason, it evolved a patchwork of articles within its Constitution and By-laws that were often outdated

and not internally consistent. We recognized that a fundamental revision was required of each document. I want to thank the CINP Constitution and By-Laws Committee, led by Professor Brian Dean, our CINP Treasurer, for the detailed and careful recommendations for revision. The EC considered their recommendations in detail and proposed a final set of revisions to the CINP membership, which voted to adopt them. The newly revised Constitution and By-laws will well serve the needs of the CINP for many years to come.

**3. Ensuring the Long-Term Financial Viability of CINP.** CINP had, over time, accumulated financial reserves that insured its security even when revenues from its biennial world congresses were sparse. However, several factors are leading CINP to change the way that it does business: 1) pharmaceutical industry support continues, but at a lower level than previously, 2) administrative costs for operating CINP continue to rise while revenues have not kept pace, and 3) the financial model for the CINP (supporting two years of administrative expenses from a single World Congress) puts enormous pressure for revenue generation on each World Congress and magnifies the impact of Congresses that do not make money. Put simply, CINP is spending down its reserves and it needs to develop a new approach to insure its long-term viability. CINP has responded by exploring ways to manage the costs of the World Congresses, expanding the scope of the Thematic Meetings between the World Congresses, and carefully managing its operating costs. I suspect that this will be a central CINP focus for many years to come.

**B. CINP Objectives.** CINP has long-standing scientific and administrative agendas that go far beyond its efforts to insure its own existence. I would like to highlight a few areas of continuing focus for CINP:

**1. Nurturing the global scientific community.** CINP meetings have long been an exceptional venue for sharing new research findings, learning about the cutting edge of science, and building friendships and collaborations around the world. In parallel, CINP has long undertaken educational activities around the world, particularly developing nations. In these countries, we have tried to raise awareness about neuroscience and to

help connect young scientists in these countries more closely to the global research communities. Over the past few years, this mission was somewhat scaled back due to resources. However, this is an area that we would like to see revitalized.

**2. Serving as an umbrella organization for national, regional, and continental colleges of neuropsychopharmacology.** CINP has a global focus, consistent with the scientific theme for the 2018 World Congress, “Neuropsychopharmacology: Meeting Global Challenges with Global Innovation.” CINP can help to bring colleges around the world together to identify and work toward realizing common objectives. Exemplars of this effort include the Neuroscience-based Nomenclature initiative that was led by incoming CINP Vice President, Professor Joseph Zohar, and the Public-Private Partnership initiative led by CINP Past-President, Professor Shigeto Yamawaki. Serving in this capacity will enable CINP to provide more support to emerging colleges, such as the African College of Neuropsychopharmacology, currently led by Professor Dan Stein.

### C. CINP Meetings

**1. Thematic Meeting on “Treatment-Resistant Depression”, Prague, 2017.** CINP held a wonderful meeting in Prague that brought together the community of investigators taking stock of the clinical and research challenges associated with treatment-resistant symptoms of depression (TRD) and the promise of the new rapid-acting antidepressants. The Local Organizing Committee was chaired by Professors Cyril Hoschl and Siegfried Kasper and the International Scientific Program Committee was led by Professors Elias Eriksson and Gerard Sanacora.

**2. World Congress in Vienna, 2018.** We excitedly look forward to our World Congress in Vienna. I would like to particularly thank Professors Barbara Sahakian and Marina Picciotto for their leadership of the International Scientific Program Committee. I would also like to thank the leader of our Local Organizing Committee, Professor Siegfried Kasper for his contributions and the efforts of his Committee to host a successful meeting.

**3. Upcoming Meetings.** CINP is already planning two upcoming meetings. These include a Thematic Meeting in **Athens, 2019** and a World Congress in **Taipei, 2020**.

**D. Expressions of gratitude and congratulations.** In addition to the people that I thanked earlier, I thank CINP members for giving me the opportunity to lead this wonderful College. I wish to particularly thank Mrs Gill Moore for her dedication to CINP, her advice, and her support. I wish her well in her future adventures. I also thank the CINP Central Office Staff for their invaluable assistance, particularly Ms Abigail Burke and Mrs Gail Massey. I think the members of the CINP EC for their dedicated service, including Past-President, Shigeto Yamawaki; President-Elect, Siegfried Kasper; Vice Presidents, Pierre Blier and Toshikazu Saito; Secretary, Elias Eriksson; Treasurer, Brian Dean; and our Councillors, Francesco Artigas, Helena Calil, Maurizio Fava, Kazutaka Ikeda, Jun Soo Kwon, Carol Tamminga, Gustavo Turecki, and Alan Young.

I congratulate the following individuals for election to CINP Office from 2018 onwards: Pierre Blier (President); Shih-Ku Lin and Joseph Zohar (Vice-Presidents); Kazutada Ikeda (Treasurer); and Katherina Domschke, Peter Falkai, Gabriella Gobbi, Ryota Hashimoto, Atsumi Nitta (Councillors).

Lastly, I congratulate CINP members for their wisdom in electing Professor Siegfried Kasper to President. I have greatly valued his collegiality and I am pleased to pass the Presidency to such an accomplished leader.



*Treasurer's Report - Prof. Brian Dean, Australia*

This is my fourth and final report as Treasurer of the CINP. I would therefore like to begin by expressing my gratitude to Gill Moore and Gail Massey at Northern Networking Events Ltd for their excellent assistance in ensuring all things financial within the CINP have been managed effectively and efficiently. I would also like to thank Fiona Struthers from AD+ for her role in auditing the financial activities of the CINP and providing excellent advice on how we manage risk. Finally, I would like to thank all the Presidents and EC members with whom I have had the pleasure in working in my time as Treasurer. They have coped with my Treasurer's voice calling for stringent management of financial affairs and, more importantly, have responded to that voice to ensure the CINP has operated with a high level of fiscal responsibility.

A major financial issue confronting the CINP recently was being changes in laws governing how Institutions manage funds in organisations that transcend national boundaries. In practical terms, this meant moving our investments from Barclays Bank because they were unable to continue to hold CINP investments due to changes in laws governing their activities. Due to pressing timelines, this has resulted in the CINP reserves being held by Kleinwort Hambros. It will be a decision of the incoming Executive Committee as to whether this is an arrangement that is optimal for the CINP or whether reserves should be spread across companies as a mechanism of managing risk.

I can also report that over the last two years the Executive Committee has striven to contain expenditure and to seek mechanisms to increase incomes. The Executive Committee is progressing toward fulfilling the recommendations of the CINP Finance Committee which was to hold annual meetings and hence lesson the peaks and troughs in income occurring because of holding one major biennial meeting. Equally, the Executive Committee have recognised the ongoing success of the World Congress after the very successful meeting held in Seoul in 2016 during the Presidency of Shigeto Yamawaki.

By the time we gather for the 2018 CINP World Congress in Vienna, the 2017 Financial Reports will be available to members and this will give a comprehensive overview of the financial activities of the CINP. In 2017 the Executive Committee decided to appoint International Conference Services to manage the affairs of the CINP. This will see our Head Office move from Glasgow and will mean CINP activities no longer be governed by the financial laws of Scotland. Managing this change and ensuring the CINP complies with any new national laws governing its activity will be one of the first issues to be managed by the new Executive Committee and their Treasurer.

It has been a pleasure to serve as the CINP Treasurer over two terms and I look forward to watching the Society continue its important contributions to the field of neuropsychopharmacology.

*Report of the Editor in Chief of the International Journal of Neuropsychopharmacology – Dr Alan Frazer*

I am pleased to present an update of the activities of the IJNP in 2016-2017.

We currently have 59 members on our editorial board and, appropriately for an international journal, there is a broad geographical distribution: 27 from Europe; 24 from North American; 6 from Asia and Australia, and 2 from South America.

Nine members were removed from the board over the past two years as their term ended.

At our Field Editors' Retreat in April 2016, it was decided that the current editorial board was sufficient to meet the review demands of the Journal and that no changes were needed. In 2017, it was decided that certain areas of expertise were needed on the board as well as more female members. So new members added in 2017 were:

In 2017, the geographical distribution of authors of submitted articles was 34% from Europe, 22% from North America, 35% from Asia, 2% from Australia and New Zealand, 5% from Latin and South America, and 2% from the Middle East.

From the World Congress in Seoul, seven review articles were published. A new series, initiated in 2015, called "Making Sense of..." has become popular. In general, these articles are meant to inform the readers of our Journal about newer techniques and areas relevant for neuropsychopharmacology. Eight of these articles have been published and three more have been submitted.

One consequence of becoming open access is that the number of visits to the Journal with content engagement has increased dramatically with such visits being 319,659 in 2017 but only 89,300 in 2014 (prior to becoming open access).

At the Field Editors' Retreat in April 2018, the following two papers were selected for the IJNP award for most cited papers in 2016-2017:

Of some note is that the Impact Factor of the Journal increased over the past two years, being 4.333 in 2015 and 4.712 in 2016.

Another piece of good news is that the Journal continues to contribute revenue for the College. Revenue for the Journal in 2016 was \$396,000 and \$304,778 in 2017 with the College receiving a percentage of the earnings.

In addition to the Editorial Board members, I would like to take the opportunity to thank the many people who make the production of IJNP possible, in particular the Field Editors, my Editorial Assistant, Ann Miller, Rachel Warren and Matt Turney, who manage the Journal for Oxford University Press (OUP), and the entire marketing and production team at OUP.
